

Monthly Air Quality Report

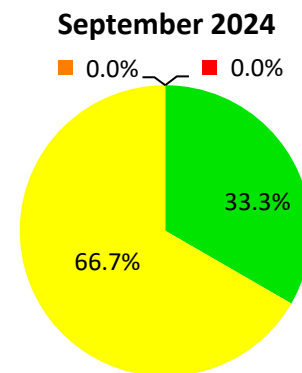
September 2024 · Birmingham, AL



SUMMARY

This report presents daily maximum Air Quality Index (AQI) values and corresponding AQI colors from five different pollutants monitored in the Birmingham area: carbon monoxide (CO), particulate matter (PM₁₀ and PM_{2.5}), ozone (O₃), and sulfur dioxide (SO₂). The table and figure below show the number of days and percentage of days in each AQI category, respectfully, for the month.

Data in this report is preliminary and has not been through quality assured and quality controlled procedures and should not be used for compliance with EPA's National Ambient Air Quality Standards (NAAQS). AQI values in this report are used for forecasting and reporting daily air quality to the public. Pollution concentration data is used for compliance with the NAAQS. AIR QUALITY ALERTS

Air quality alerts are issued for days that are forecast to have AQI values greater than 100 for O₃ and/or PM_{2.5}. O₃ is forecast by the Alabama Department of Environmental Management during the warm season. PM_{2.5} is forecast by the Jefferson County Department of Health year-round.

No air quality alerts were issued in September. There have been a total of 8 air quality alerts issued in 2024 through September.
