

# Monthly Air Quality Report

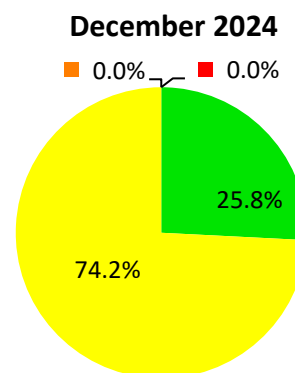
## December 2024 · Birmingham, AL



### SUMMARY

This report presents daily maximum Air Quality Index (AQI) values and corresponding AQI colors from five different pollutants monitored in the Birmingham area: carbon monoxide (CO), particulate matter (PM<sub>10</sub> and PM<sub>2.5</sub>), ozone (O<sub>3</sub>), and sulfur dioxide (SO<sub>2</sub>). The table and figure below show the number of days and percentage of days in each AQI category, respectfully, for the month.

## AIR QUALITY ALERTS

Air quality alerts are issued for days that are forecast to have AQI values greater than 100 for O<sub>3</sub> and/or PM<sub>2.5</sub>. O<sub>3</sub> is forecast by the Alabama Department of Environmental Management during the warm season. PM<sub>2.5</sub> is forecast by the Jefferson County Department of Health year-round.

No air quality alerts were issued in December. There has been a total of 8 air quality alerts issued in 2024 through December.
